**Declaration of Quorum and Call to Order:**

President Schorp declared a quorum present by roll call and called the meeting to order at 9:08 a.m. The meeting was posted and filed as required by law.

**Public Hearing- Water Well Drilling and Production Permit Applications**

The Board was presented with one drilling and production permit application for Verdun Oil Company (Drilling/Production Permit#3048) for a new well to be located in Atascosa County for Industrial use. Director Bartek moved to approve the drilling and production permit. Director Riggs seconded the motion, and there being no further discussion the motion carried unanimously.

The Board was presented with one drilling and production permit application for Spicer Sigman (Drilling/Production Permit#3049) for a new well to be located in Frio County for Irrigation use. Director Neal moved to approve the drilling and production permit. Director Bartek seconded the motion, and there being no further discussion the motion carried unanimously.

The Board was presented with one amended well for Brandon Smith (Production Permit #1514) located in Atascosa County for Industrial use originally permitted for Irrigation use. ### **Report on Monitor Well Program:**

Landon Yosko said that the monitor wells in Atascosa County are completed, and he is now continuing the program into Wilson County. Mr. Yosko mentioned that he wants to place five wells in the outcrop focusing on the western portion of the county. Mr. Yosko showed on the map where he would like to put the monitor wells. Mr. Yosko said once locations have been determined then we will present the project to the Wilson County Commissioner’s Court for their approval.

### **Update on Education Program with Region 20:**

Director Riggs mentioned that he spoke with a representative with Region 20 and they gave him different scenarios on what they do with schools and other entities. Director Riggs said that he let them know that we would like something by August and suggested having one of their representatives give a presentation at one of our meetings.

Landon Yosko mentioned that Dale Rankin, with the Atascosa County Extension Service, called and asked if the Evergreen would like to give a presentation at the South Texas Peanut Growers Association Annual Meeting. Mr. Yosko said he will prepare a presentation to present at the meeting.
