Mr. Yosko informed the board that he received a complaint on Wednesday about the grass farms irrigating nonstop and that her well has been depleted. Mr. Yosko said that sooner or later we will need to confront the issue of the ones who utilize the 2-acre feet and impact neighboring wells.
