Call Permit Hearing to Order

1. Permit Hearing for the following **Drilling/Production Permit Applications:**

- **One (1) new well for South Texas Frac (Drilling Permit #3067, Production Permit #3067)** located at N 29.096769, W -98.236734, in Wilson County for Industrial use. The total acreage of the property is 1,969. The well will produce from the Carrizo Aquifer at a proposed depth of 1,000ft. The proposed capacity of the well is 1,800 GPM. Total maximum annual production from the well will be 2,176.56 acre feet based on 75% capacity of the well. This will be the second well on the property.
- **One (1) new well for 181 Cattle Company (Drilling Permit #3070, Production Permit #3070)** located at N 29.117210, W -98.119250, in Wilson County for Irrigation use. The total acreage of the property is 180. The well will produce from the Carrizo Aquifer at a proposed depth of 1200ft. The proposed capacity of the well is 600 GPM. Total maximum annual production from the well will be 360 acre feet based on 2 acre feet.
- **One (1) new well for Jones/Naegelin (Drilling Permit #3071, Production Permit #3071)** located at N 28.733278, W -99.283722, in Frio County for Irrigation use. The total acreage of the property is 2218.66. The well will produce from the Carrizo Aquifer at a proposed depth of 1850ft. The proposed capacity of the well is 1000 GPM. Total maximum annual production from the well will be 493.03 acre feet based on 2 acre feet.
- **One (1) new well for SS Water Supply Corporation (Drilling Permit #3072, Production Permit #3072)** located at N 29.190106, W -98.105183, in Wilson County for Public Supply use. The total system allotment is based on 600 gallons per connection per day. The well will produce from the Carrizo Aquifer at a proposed depth of 1,110 ft. The proposed capacity of the well is 600 GPM. Total maximum annual production from the well will be 387.7 acre feet based on 6,922 connection and 12 wells.



- **One (1) new well for SS Water Supply Corporation (Drilling Permit #3073, Production Permit #3073)** located at N 29.288077, W -98.116903, in Wilson County for Public Supply use. The total system allotment is based on 600 gallons per connection per day. The well will produce from the Carrizo Aquifer at a proposed depth of 460 ft. The proposed capacity of the well is 1,000 GPM. Total maximum annual production from the well will be 387.7 acre feet based on 6,922 connection and 12 wells.
- **One (1) new well for SS Water Supply Corporation (Drilling Permit #3074, Production Permit #3074)** located at N 29.300926, W -98.114339, in Wilson County for Public Supply use. The total system allotment is based on 600 gallons per connection per day. The well will produce from the Carrizo Aquifer at a proposed depth of 495 ft. The proposed capacity of the well is 500 GPM. Total maximum annual production from the well will be 387.7 acre feet based on 6,922 connection and 12 wells.

2. Permit Hearing for the following **Permit on existing wells:**

- **One (1) well for Jones/Nagelin (Production Permit #3075)** located at N 28.722797, W -99.300423, in Frio County for Irrigation use. The total acreage of the property is 2218.66. The well produces from the Carrizo Aquifer at a depth of 1,850 ft. The capacity of the well is 1,000 GPM. Total maximum annual production from the well will be 493.03 acre feet based on 2 acre feet.
