Call Permit Hearing to Order

- 1. Permit Hearing for the following **Drilling/Production Permit Applications**:
 - One (1) new well for Del Flores Jr. (Drilling Permit #3076, Production Permit #3076) located at N 28.988778, W -98.766722, in Atascosa County for Irrigation use. The total acreage of the property is 235. The well will produce from the Carrizo Aquifer at a proposed depth of 1,000ft. The proposed capacity of the well is 1,000 GPM. Total maximum annual production from the well will be 235 acre feet based on 2 acre feet. This will be the second well on the property.
 - One (1) new well for JGF Properties (Drilling Permit #3077, Production Permit #3077) located at N 29.314444, W -98.175000, in Wilson County for Industrial use. The total acreage of the property is 125. The well will produce from the Wilcox Aquifer at a proposed depth of 900ft. The proposed capacity of the well is 325 GPM. Total maximum annual production from the well will be 250 acre feet based on 2 acre feet. Only well on property.
 - One (1) new well for Gary Boyd Farms (Drilling Permit #3078, Production Permit #3078) located at N 28.779778, W -99.087672, in Frio County for Irrigation use. The total acreage of the property is 1413. The well will produce from the Carrizo Aquifer at a proposed depth of 1850ft. The proposed capacity of the well is 1000 GPM. Total maximum annual production from the well will be 942 acre feet based on 2 acre feet. This will be the 3rd well on the property.
 - One (1) new well for H&H Livestock (Drilling Permit #3081, Production Permit #3081) located at N 28.744297, W -98.987431, in Frio County for Irrigation use. The total acreage of the property is 9720. The well will produce from the Carrizo Aquifer at a proposed depth of 2050ft. The proposed capacity of the well is 1000 GPM. Total maximum annual production from the well will be 1209.2 acre feet based on 2 acre feet. This will be the 2nd well on the property.



- One (1) new well for Mike Pawelek (Drilling Permit #3082, Production Permit #3082) located at N 28.998746, W –97.915075, in Karnes County for Irrigation use. The total acreage of the property is 250. The well will produce from the Yegua-Jackson Aquifer at a proposed depth of 650ft. The proposed capacity of the well is 350 GPM. Total maximum annual production from the well will be 423.41 acre feet based on 75% capacity of well. This will be the only well on the property.
- One (1) new well for FJL Venture Group LLC. (Drilling Permit #3083, Production Permit #3083) located at N 28.867, W -98.869, in Frio County for Irrigation use. The total acreage of the property is 683. The well will produce from the Carrizo Aquifer at a proposed depth of 1,600ft. The proposed capacity of the well is 1,000 GPM. Total maximum annual production from the well will be 455.3 acre feet based on 2 acre feet. This will be the 3rd well on the property.
- One (1) new well for Mike Pawelek (Drilling Permit #3084, Production Permit #3084) located at N 28.993932, W -97.850845, in Karnes County for Irrigation use. The total acreage of the property is 137. The well will produce from the Yegua-Jackson Aquifer at a proposed depth of 650ft. The proposed capacity of the well is 350 GPM. Total maximum annual production from the well will be 91.33 acre feet based on 2 acre feet. This will be the 3rd well on the property.
- 2. Permit Hearing for the following **Permit on Existing Wells:**
 - One (1) well for Gary Boyd Farms (Production Permit #3079) located at N 28.782222, W -99.083861, in Frio County for Irrigation use. The total acreage of the property is 1413. The well produces from the Carrizo Aquifer at a depth of 1,850 ft. The capacity of the well is 1,000 GPM. Total maximum annual production from the well will be 942 acre feet based on 2 acre feet. 3 total wells on property.
 - One (1) well for Gary Boyd Farms (Production Permit #3080) located at N 28.774000, W -99.095972, in Frio County for Irrigation use. The total acreage of the property is 1413. The well produces from the Carrizo Aquifer at a depth of 1,850 ft. The capacity of the well is 1,000 GPM. Total maximum annual production from the well will be 942 acre feet based on 2 acre feet. 3 total wells on property.



- 3. Permit Hearing for the following **Permit Amendment:**
 - One (1) well for Peter Mutz (Production Permit #2976) located at N 29.056484, W -- 97.986795 in Wilson County for Irrigation use. The total acreage of the property is 330. The well produces from the Yegua-Jackson Aquifer at a depth of 300 ft. The capacity of the well is 50 GPM. Total maximum annual production from the well will be 60.46 acre feet based on 75% Capacity. 2 total wells on property.
