Call Permit Hearing to Order

1. Permit Hearing for the following **Drilling/Production Permit Applications:**

- **One (1) new well for Thundering Hooves Ranch (Drilling Permit #2992, Production Permit #2992)** located at N 29.208513, W -98.184823, in Wilson County for Irrigation use. The total acreage of the property is 211. The well will produce from the Carrizo Aquifer at a proposed depth of 700 ft. The proposed capacity of the well is 500 GPM. Total maximum annual production from the well will be 422 acre feet based on 2 acre feet per acre. Only well on property.
- **One (1) new well for Robert Flores (Drilling Permit #2993, Production Permit #2993)** located at N 29.016467, W -99.199044, in Frio County for Irrigation use. The total acreage of the property is 1001. The well will produce from the Carrizo Aquifer at a proposed depth of 750 ft. The proposed capacity of the well is 500 GPM. Total maximum annual production from the well will be 604.88 acre feet based on 75% capacity and will be 2nd well on property.
- **One (1) new well for The Grass Yard (Drilling Permit #2994, Production Permit #2994)** located at N 29.035333, W -98.815194, in Frio County for Irrigation use. The total acreage of the property is 584. The well will produce from the Carrizo Aquifer at a proposed depth of 700 ft. The proposed capacity of the well is 500 GPM. Total maximum annual production from the well will be 389.33 acre feet based on 2 acre feet per acre. This will be the 3rd well.
- **One (1) new well for Hiner Ranch Operating (Drilling Permit #2996, Production Permit #2996)** located at N 28.670917, W -99.223750, in Frio County for Irrigation use. The total acreage of the property is 1830. The well will produce from the Carrizo Aquifer at a proposed depth of 2100 ft. The proposed capacity of the well is 1000 GPM. Total maximum annual production from the well will be 1209.75 acre feet based on 75% capacity and will be 2nd well on property



- **One (1) new well for Road Ranger (Drilling Permit #2998, Production Permit #2998)** located at N 29.031144, W -99.048944, in Frio County for Industrial use. The total acreage of the property is 12 acres. The well will produce from the Carrizo Aquifer at a proposed depth of 900 ft. The proposed capacity of the well is 35 GPM. Total maximum annual production from the well will be 24 acre feet based on 2 acre feet.
- **One (1) new well for City of Pleasanton (well #10) (Drilling Permit #2999, Production Permit #2999)** located at N 28.958836, W -98.503217, in Atascosa County for Public Supply use. The total acreage of the property is CCN. The well will produce from the Carrizo Aquifer at a proposed depth of 1790 ft. The proposed capacity of the well is 1000 GPM. Total maximum annual production from the well will be 315.73 acre feet based on 4700 connections x 600 gpcd x 365 days. Divided by 10 wells.

2. Permit Hearing for the following **Permit on Existing Wells:**

- **One (1) well for The Grass Yard (Production Permit #2995)** located at N 29.026889, W -98.817928, in Frio County for Irrigation use. The total acreage of the property is 584. The well produces from the Carrizo Aquifer. Total maximum annual production from the well will be 389.33 acre feet based on 2 acre feet per acre. This is the 3rd well on the property.
- **One (1) well for Hiner Ranch Operating (Production Permit #2997)** located at N 28.666284, W -99.226254, in Frio County for Irrigation use. The total acreage of the property is 1830. The well produces from the Carrizo Aquifer. Total maximum annual production from the well will be 302.3 acre feet based on 75% capacity. This is the 2nd well on the property.
