Call Permit Hearing to Order

- 1. Permit Hearing for the following **Drilling/Production Permit Applications**:
 - One (1) new well for Kent Schwartz (Drilling Permit #3128, Production Permit #3128) located at N 28.937438 W -98.589969, in Atascosa County for Irrigation use. The total acreage of the property is 2,707.85. The well will produce from the Carrizo Aquifer at a proposed depth of 1,650ft. The proposed capacity of the well is 1,500 GPM. Total maximum annual production from the well will be 903 acre feet based on two acre feet. This is the 6th well on the property.
 - One (1) new well for Kent Schwartz (Drilling Permit #3127, Production Permit #3127) located at N 28.944265, W -98.603556, in Atascosa County for Irrigation use. The total acreage of the property is 2,707.85. The well will produce from the Carrizo Aquifer at a proposed depth of 1,650ft. The proposed capacity of the well is 1,500 GPM. Total maximum annual production from the well will be 903 acre feet based on 2 acre feet. This is the 6th well on the property.
 - One (1) new well for E L Ranch (Drilling Permit #3129, Production Permit #3129) located at N 28.725043, W -98.772317, in Atascosa County for Irrigation use. The total acreage of the property is 11,577.425. The well will produce from the Carrizo Aquifer at a proposed depth of 2,550ft. The proposed capacity of the well is 1,200 GPM. Total maximum annual production from the well will be 1,451.7 acre feet based on 75% capacity of well. This is the 6th well on the property.
 - One (1) new well for Acres, Agua & Ag (Drilling Permit #3131, Production Permit #3131) located at N 29.057420, W -98.753189, in Atascosa County for Irrigation use. The total acreage of the property is 283. The well will produce from the Carrizo Aquifer at a proposed depth of 620ft. The proposed capacity of the well is 500 GPM. Total maximum annual production from the well will be 141.64 acre feet based on 2 acre feet. This is the 4th well on the property.



• One (1) new well for Dorothy Gross (Drilling Permit #3134, Production Permit #3134) located at N 28.846392, W -97.869876, in Karnes County for Industrial use. The total acreage of the property is 435.91. The well will produce from the Yegua Aquifer at a proposed depth of 3,000ft. The proposed capacity of the well is 400 GPM. Total maximum annual production from the well will be 483.9 acre feet based on 75% capacity of well.

2. Permit Hearing on Existing Wells:

• One (1) new Permit for E L Ranch (Production Permit #3130) located at N 28.724741, W -98.768423, in Atascosa County for Irrigation use. The total acreage of the property is 11,577.425 The well produces from the Carrizo Aquifer. The proposed capacity of the well is 1,200 GPM. Total maximum annual production from the well will be 1,451.7 acre feet.
