Call Permit Hearing to Order

- 1. Permit Hearing for the following **Drilling/Production Permit Applications**:
 - One (1) new well for Roger Kincaid (Drilling Permit #3092, Production Permit #3092) located at N 29.190266, W -98.063774, in Wilson County for Irrigation use. The well will produce from the Queen City Aquifer at a proposed depth of 550ft. The proposed capacity of the well is 400 GPM. Total maximum annual production from the well will be 483.68 acre feet based on 75% capacity of the pump. This is the second well on the property.
 - One (1) new well for Pearsall TX Crops (Drilling Permit #3093, Production Permit #3093) located at N 28.777125, W -99.050622, in Frio County for Irrigation use. The well will produce from the Carrizo Aquifer at a proposed depth of 1,800ft. The proposed capacity of the well is 1,200 GPM. Total maximum annual production from the well will be 625.2 acre feet based on 75% capacity of the pump. This will be the 5th well on the property.
 - One (1) new well for LLV Ranch (Drilling Permit #3094, Production Permit #3094) located at N 28.79546, W -99.25250, in Frio County for Irrigation use. The well will produce from the Carrizo Aquifer at a proposed depth of 1,836ft. The proposed capacity of the well is 250 GPM. Total maximum annual production from the well will be 302.3 acre feet based on 75% capacity. This is the only well on the property.
 - One (1) new well for Rodina Ranch LTD (Drilling Permit #3095, Production Permit #3095) located at N 28.976235, W -98.387060, in Atascosa County for Irrigation use. The well will produce from the Carrizo Aquifer at a proposed depth of 1,950ft. The proposed capacity of the well is 200 GPM. Total maximum annual production from the well will be 241.84 acre feet based on 75% capacity of the pump. This is the only well on the property.



- One (1) new well for Mark Cluck (Drilling Permit #3096, Production Permit #3096) located at N 29.24766, W -97.81008, in Wilson County for Irrigation use. The total acreage of the property is 5,800. The well will produce from the Carrizo Aquifer at a proposed depth of 1,600ft. The proposed capacity of the well is 1,500 GPM. Total maximum annual production from the well will be 1,288.88 acre feet based on 2 acre feet. This will be the 9th well on the property.
- One (1) new well for Taylor Floyd (Drilling Permit #3097, Production Permit #3097) located at N 28.947278, W -99.088903, in Frio County for Industrial use. The well will produce from the Carrizo Aquifer at a proposed depth of 1,400ft. The proposed capacity of the well is 400 GPM. Total maximum annual production from the well will be 483.68 acre feet based on 75% capacity of the pump. This will be the 3rd well on the property.
