Call Permit Hearing to Order

1. Permit Hearing for the following **Drilling/Production Permit Applications**:

- **One (1) new well for King Ranch Turfgrass (Drilling Permit #3167 Production Permit #3167)** located at N 28.994, W -99.327, in Frio County for Irrigation use. The total acreage of the property is 2121.72. The well will produce from the Carrizo Aquifer at a proposed depth of 650ft. The proposed capacity of the well is 800 GPM. Total maximum annual production from the well will be 707.56 acre feet based on 2 acre ft. This is the 7th well on the property.
- **One (1) new well for Wesla Ranches, LLC (Drilling Permit #3168 Production Permit #3168)** located at N 29.057520, W -98.827690, in Frio County for Irrigation use. The total acreage of the property is 415 acres. The well will produce from the Carrizo Aquifer at a proposed depth of 632ft. The proposed capacity of the well is 1000 GPM. Total maximum annual production from the well will be 207.5 acre feet based on 2 acre ft. This is the 4th well on the property.

2. Permit Hearing for Amendment to Increase Production on **Existing Wells**:

- **One (1) new Permit for Oak Hills WSC (Production Permit #2194)** located at N 29.192611, W -98.198833, in Wilson County for Public Supply use. The total acreage of the property is 3. The well produces from the Carrizo Aquifer. The proposed capacity of the well is 1,826 GPM. Total maximum annual production from the well will be 348.64 acre feet. This is an increase from 103,000,000 gallons (316.10 ac-ft) to 113,606,250 gallons (348.64 ac-ft) annually.

3. Permit Hearing **on Existing Wells**:

- **One (1) new Permit for Oak Hills WSC (Production Permit #3156)** located at N 29.194167, W -98.198334, in Wilson County for Public Supply use. The total acreage of the property is 3. The well produces from the Carrizo Aquifer. The proposed capacity



of the well is 350 GPM. Total maximum annual production from the well will be 348.64 acre feet.

- **One (1) new Permit for Oak Hills WSC (Production Permit #3157)** located at N 29.224712, W -98.243042, in Wilson County for Public Supply use. The total acreage of the property is 4.17. The well produces from the Carrizo Aquifer. The proposed capacity of the well is 350 GPM. Total maximum annual production from the well will be 348.64 acre feet.
- **One (1) new Permit for Oak Hills WSC (Production Permit #3158)** located at N 29.224444, W -98.243889, in Wilson County for Public Supply use. The total acreage of the property is 4.17. The well produces from the Carrizo Aquifer. The proposed capacity of the well is 300 GPM. Total maximum annual production from the well will be 348.64 acre feet.
- **One (1) new Permit for City of Charlotte (Production Permit #3152)** located at N 28.865964, W -98.708236, in Atascosa County for Public Supply use. The total acreage of the property is 1. The well produces from the Carrizo Aquifer. The proposed capacity of the well is 475 GPM. Total maximum annual production from the well will be 251.70 acre feet.
- **One (1) new Permit for City of Charlotte (Production Permit #3151)** located at N 28.863110, W -98.707863, in Atascosa County for Public Supply use. The total acreage of the property is 0.48. The well produces from the Carrizo Aquifer. The proposed capacity of the well is 475 GPM. Total maximum annual production from the well will be 251.70 acre feet.
- **One (1) new Permit for City of Christine (Production Permit #3150)** located at N 28.78883, W -98.497009, in Atascosa County for Public Supply use. The total acreage of the property is 2.73. The well produces from the Carrizo Aquifer. The proposed capacity of the well is 336 GPM. Total maximum annual production from the well will be 61.5 acre feet.
- **One (1) new Permit for City of Christine (Production Permit #3149)** located at N 28.78853, W -98.497002, in Atascosa County for Public Supply use. The total acreage of the property is 2.73. The well produces from the Carrizo Aquifer. The proposed capacity of the well is 415 GPM. Total maximum annual production from the well will be 61.5 acre feet.
- **One (1) new Permit for King Ranch Turfgrass (Production Permit #3163)** located at N 28.9975, W -99.33, in Frio County for Irrigation use. The total acreage of the



property is 2121.72. The well produces from the Carrizo Aquifer. The proposed capacity of the well is 800 GPM. Total maximum annual production from the well will be 707.56 acre feet.

- **One (1) new Permit for King Ranch Turfgrass (Production Permit #3164)** located at N 29.001696, W -99.326076, in Frio County for Irrigation use. The total acreage of the property is 2121.72. The well produces from the Carrizo Aquifer. The proposed capacity of the well is 675 GPM. Total maximum annual production from the well will be 707.56 acre feet.
- **One (1) new Permit for King Ranch Turfgrass (Production Permit #3165)** located at N 28.999167, W -99.33822, in Frio County for Irrigation use. The total acreage of the property is 2121.72. The well produces from the Carrizo Aquifer. The proposed capacity of the well is 800 GPM. Total maximum annual production from the well will be 707.56 acre feet.
- **One (1) new Permit for King Ranch Turfgrass (Production Permit #3166)** located at N 28.993056, W -99.320555, in Frio County for Irrigation use. The total acreage of the property is 2121.72. The well produces from the Carrizo Aquifer. The proposed capacity of the well is 950 GPM. Total maximum annual production from the well will be 707.56 acre feet.
