Call Permit Hearing to Order

- 1. Permit Hearing for the following **Drilling/Production Permit Applications**:
 - One (1) new well for Christian Faith Center (Production Permit #3180) located at N 28.711254, W -99.160004, in Frio County for Transient Non-Community Water Supply use. The total acreage of the property is 15.56. The well will produce from the Queen City Aquifer at a proposed depth of 350ft. The proposed capacity of the well is 200 GPM. Total maximum annual production from the well will be 31.12 acre-feet based on 2 acre ft. This is the 1st well on the property.
 - One (1) new well for the City of Stockdale (Production Permit #3185) located at N 29.233925, W -97.950236, in Wilson County for Public Supply use. The total acreage of the property is 5. The well will produce from the Carrizo Aquifer at a proposed depth of 1,000 ft. The proposed capacity of the well is 1,200 GPM. Total maximum annual production from the well will be 159.51 acre-feet based on 2 acre ft. This is the 2nd well on the property.
 - One (1) new well for Gary & April Fritz (Production Permit #3183) located at N 29.061403, W -98.799983, in Atascosa County for Irrigation use. The total acreage of the property is 1,718.39. The well will produce from the Carrizo Aquifer at a proposed depth of 540 ft. The proposed capacity of the well is 800 GPM. Total maximum annual production from the well will be 859.20 acre-feet based on 2 acre ft. This is the 4th well on the property.
 - One (1) new well for Hondo Turf LLC (Production Permit #3174) located at N 29.004175, W -98.922717, in Frio County for Irrigation use. The total acreage of the property is 615.85. The well will produce from the Carrizo Aquifer at a proposed depth of 900 ft. The proposed capacity of the well is 1,000 GPM. Total maximum annual production from the well will be 410.57 acre-feet based on 2 acre ft. This is the 1st well on the property.



- One (1) new well for Hondo Turf LLC (Production Permit #3175) located at N 28.998008, W -98.923067, in Frio County for Irrigation use. The total acreage of the property is 615.85. The well will produce from the Carrizo Aquifer at a proposed depth of 900 ft. The proposed capacity of the well is 1,000 GPM. Total maximum annual production from the well will be 410.57 acre-feet based on 2 acre ft. This is the 2nd well on the property.
- One (1) new well for King Ranch Turfgrass, LP (Production Permit #3181) located at N 29.079456, W -98.745417, in Atascosa County for Irrigation use. The total acreage of the property is 1,277.3. The well will produce from the Carrizo Aquifer at a proposed depth of 550 ft. The proposed capacity of the well is 1,000 GPM. Total maximum annual production from the well will be 425.96 acre-feet based on 2 acre ft. This is the 6th well on the property.
- One (1) new well for Hardip Singh (Production Permit #3186) located at N 28.939698, W -98.254487, in Atascosa County for Irrigation use. The total acreage of the property is 200. The well will produce from the Carrizo Aquifer at a proposed depth of 3,100 ft. The proposed capacity of the well is 650 GPM. Total maximum annual production from the well will be 400.18 acre-feet based on 2 acre ft. This is the only well on the property.
- 2. Permit Hearing for Amendment to Increase Production on Existing Wells:
 - One (1) new Permit for Gary & April Fritz (Production Permit #2543) located at N 29.06966, W -98.79752, in Atascosa County for Irrigation use. The total acreage of the property is 1,718.39. The well produces from the Carrizo Aquifer. The proposed capacity of the well is 800 GPM. Total maximum annual production from the well will be 859.2 acre feet. This is an increase from 623.72 ac-ft to 859.2 ac-ft annually.
- 3. Permit Hearing on Existing Wells:
 - One (1) new Permit for Morales Resources (Production Permit #3176) located at N 28.710556, W -99.043611, in Frio County for Irrigation use. The total acreage of the property is 1,367.70. The well produces from the Carrizo Aquifer. The proposed capacity of the well is 1,000 GPM. Total maximum annual production from the well will be 683.85 acre feet.
