Call Permit Hearing to Order

- 1. Permit Hearing for the following **Drilling/Production Permit Applications**:
 - One (1) new well for JMNCC, LLC (Drilling Permit #3251 and Production Permit #3251) located at N 28.984851, W -99.318209, in Frio County for Irrigation use. The total acreage of the property is 423.14. The well will produce from the Queen City Aquifer at a proposed depth of 620.00 ft. The proposed capacity of the well is 350 GPM. Total maximum annual production from the well will be 423.41 acre-feet based on 2 acre feet. This is the first permitted well on the property.
 - One (1) new well for Duane Richter (Drilling Permit #3271 and Production Permit #3271) located at N 29.131111, W -98.076111, in Wilson County for Irrigation use. The total acreage of the property is 162.52. The well will produce from the Queen City Aquifer at a proposed depth of 700.00 ft. The proposed capacity of the well is 300 GPM. Total maximum annual production from the well will be 325.04 acre-feet based on 2 acre feet. This is the first permitted well on the property.
 - One (1) new well for Duane Richter (Drilling Permit #3274 and Production Permit #3274) located at N 29.207222, W -98.061389, in Wilson County for Irrigation use. The total acreage of the property is 127.19. The well will produce from the Carrizo Aquifer at a proposed depth of 700.00 ft. The proposed capacity of the well is 300 GPM. Total maximum annual production from the well will be 127.19acre-feet based on 2 acre feet. This is the 1st of 2 proposed permitted wells on the property.
 - One (1) new well for Duane Richter (Drilling Permit #3275 and Production Permit #3275) located at N 29.209167, W -98.064722, in Wilson County for Irrigation use. The total acreage of the property is 127.19. The well will produce from the Carrizo Aquifer at a proposed depth of 700.00 ft. The proposed capacity of the well is 300 GPM. Total maximum annual production from the well will be 127.19 acre-feet based on 2 acre feet. This is the 2nd of 2 proposed permitted wells on the property



- One (1) new well for WL Cattle Co, LLC (Drilling Permit #3255 and Production Permit #3255) located at N 29.019659, W -98.355207, in Atascosa County for Irrigation use. The total acreage of the property is 260.45. The well will produce from the Carrizo Aquifer at a proposed depth of 1900 ft. The proposed capacity of the well is 1,000 GPM. Total maximum annual production from the well will be 520.9 acre-feet based on 2 acrefeet. This is the first permitted well on the property.
- One (1) new well for Wesla Ranches, LLC (Drilling Permit #3268 and Production Permit #3268) located at N 29.072847, W -98.870244, in Frio County for Irrigation use. The total acreage of the property is 358.93. The well will produce from the Carrizo Aquifer at a proposed depth of 520 ft. The proposed capacity of the well is 1,000 GPM. Total maximum annual production from the well will be 239.29 acre-feet based on 2 acre-feet. This is the 1 of 3 permitted wells on the property.
- 2. Permit Hearing for **Amendment** to Increase Production on **Existing Wells**:
 - One (1) well for James E & Arlene Seay Trustees (Production Permit #1883) located at N 29.106983, W -98.464556, in Atascosa County for Irrigation use. The total acreage of the property is 350. The well produces from the Carrizo Aquifer at a depth of 520 ft. The capacity of the well is 800 GPM. Total maximum annual production from the well will be 350 acre-feet based on 2 acre-feet. This is the 1st of 2 permitted wells on the property. The original annual production from the well was 171.88 acre-feet. This is an increase of 178.12 acre-feet.
 - One (1) well for La Iglesia del Senor (Production Permit #2807) located at N 29.116144, W -97.709794, in Karnes County for Industrial use. The total acreage of the property is 140.78. The well produces from the Carrizo Aquifer at a depth of 4211 ft. The capacity of the well is 250 GPM. Total maximum annual production from the well will be 422.34 acre-feet based on 3 acre-feet according to Rule 10.1. This is the only permitted well on the property. The original annual production from the well was 281.56 acre-feet. This is an increase of 140.78 acre-feet.

- 4. Permit Hearing for **Amendment** to Change Well Production Capacity:
 - One (1) well for La Iglesia del Senor (Production Permit #2807) located at N 29.116144, W -97.709794, in Karnes County for Industrial use. The total acreage of the property is 140.78. The well produces from the Carrizo Aquifer at a depth of 4211 ft. The capacity of the well is 1,800 GPM. Total maximum annual production from the well will be 422.34 acre-feet based on 3 acre-feet according to Rule 10.1. This is the only permitted well on the property. The original permitted maximum instantaneous flow rate from the well was 250 GPM. This is an increase of 1,550 GPM.
