Call Permit Hearing to Order

- 1. Permit Hearing for the following **Drilling/Production Permit Applications**:
 - One (1) new well for Larson 5 Ranches (Drilling Permit #3279 and Production Permit #3279) located at N 28.645068, W -99.230871, in Frio County for Irrigation use. The total acreage of the property is 129. The well will produce from the Wilcox- Hooper Aquifer at a proposed depth of 3,500 ft. The capacity of the well will be 550 GPM. Total annual production from the well will be 258 acre-feet based on 2 acre feet. This is the first permitted well on the property.
 - One (1) new well for Peeler Four Star Holdings, LLC (Drilling Permit #3288 and Production Permit #3288) located at N 28.889546, W -98.817609, in Frio County for Irrigation use. The total acreage of the property is 1190.70. The well will produce from the Carrizo Aquifer at a proposed depth of 1650 ft. The capacity of the well will be 1,000 GPM. Total annual production from the well will be 595.35 acre-feet based on 2 acre feet. This is 1 of 4 permitted wells on the property.
 - One (1) new well for The Warnken Family Partnership. LTD. (Drilling Permit #3286 and Production Permit #3286) located at N 29.020277, W 98.141577, in Wilson County for Irrigation use. The total acreage of the property is 532.33. The well will produce from the Carrizo Aquifer at a proposed depth of 3,135 ft. The capacity of the well will be 1,000 GPM. Total annual production from the well will be 532.33 acre-feet based on 2 acre feet. This is 1 of 2 permitted wells on the property.
 - One (1) new well for JLowe Properties, LTD (Drilling Permit #3287 and Production Permit #3287) located at N 28.943940, W -98.618923, in Atascosa County for Irrigation use. The total acreage of the property is 177.49. The well will produce from the Queen City Aquifer at a proposed depth of 1,060ft. The capacity of the well will be 1,000 GPM. Total annual production from the well will be 177.49 acre-feet based on 2 acre feet. This is 1 of 2 permitted wells on the property.



- One (1) new well for Wesla Ranches, LLC (Drilling Permit #3295 and Production Permit #3295) located at N 28.979029, W -98.924128, in Frio County for Irrigation use. The total acreage of the property is 867.14. The well will produce from the Carrizo Aquifer at a proposed depth of 1,000ft. The capacity of the well will be 1,000 GPM. Total annual production from the well will be 578.27 acre-feet based on 2 acre feet. This is 1 of 3 permitted wells on the property.
- One (1) new well for Casey Bartek (Drilling Permit #3297 and Production Permit #3297) located at N 29.060930, W -98.540864, in Atascosa County for Irrigation use. The total acreage of the property is 262.47. The capacity of the well will be 1,000 GPM. The well will produce from the Carrizo Aquifer at a proposed depth of 1,100ft. Total annual production from the well will be 262.47 acre-feet based on 2 acre feet. This is 1 of 2 permitted wells on the property.
- 2. Permit Hearing for **Amendment** to Increase Production on **Existing Wells**:

- 3. Permit Hearing for **Amendment** to Change Location:
 - One (1) new well for The City of Stockdale (Drilling Permit #3185 and Production Permit #3185) located at N 29.234122, W -97.950975, in Wilson County for Public Supply use. The total acreage of the property is 4.25. The well will produce from the Carrizo Aquifer at a proposed depth of 1,000 ft. The capacity of the well will be 1,200 GPM. Total maximum annual production from the well will be 159.51 acre-feet based on number of connections. This is 1 of 3 permitted wells within the public supply system. The original location of the well was permitted for N 29.233225, W -97.951613.
 - One (1) new well for Lorraine Schorsch (Drilling Permit #3230 and Production Permit #3230) located at N 28.871833 W -98.579917, in Atascosa County for Irrigation use. The total acreage of the property is 862.92. The well will produce from the Carrizo Aquifer at a proposed depth of 2,000 ft. The proposed capacity of the well is 900 GPM. Total maximum annual production from the well will be 808.48 acre-feet based on based on 2 acre ft. This is 1 of 3 wells on the property. The original permitted location was N 28.873022, W -98.578997 approximately 554 feet from the new location.
