Call Permit Hearing to Order

- 1. Permit Hearing for the following **Drilling/Production Permit Applications**:
 - One (1) new well for Travis Lynch Estate (Drilling Permit #3090 and Production Permit #3090) located at N 29.113801, W -97.740755, in Karnes County for Irrigation use. The total acreage of the property is 1,789.91. The well will produce from the Carrizo Aquifer at a proposed depth of 3,800 ft. The capacity of the well will be 2,500 GPM. Total annual production from the well will be 1,789.91 acre-feet based on 2-acre feet. This is one of two permitted well on the property.
 - One (1) new well for Frio County Paloma Partners LLC (Drilling Permit #3314 and Production Permit #3314) located at N 29.081251, W 99.107440, in Frio County for Irrigation use. The total acreage of the property is 391.27. The well will produce from the Carrizo Aquifer at a proposed depth of 700 ft. The capacity of the well will be 250 GPM. Total annual production from the well will be 260.85 acre-feet based on 2-acre feet. This is one of three permitted well on the property.
- 2. Permit Hearing for the following **Drilling/Production Permit Applications for P-13 Conversion Wells**:
 - One (1) converted well for Travis Lynch Estate (Drilling Permit #3309 and Production Permit #3309) located at N 29.132778, W -97.740556, in Karnes County for Irrigation use. The total acreage of the property is 1,789.91. The well will produce from the Carrizo Aquifer at a proposed depth of 3,800 ft. The capacity of the well will be 500 GPM. Total annual production from the well will be 604.88 acre-feet based on 75% of pumps capacity. This is one of two permitted well on the property.
- 3. Permit Hearing for **Amendment** to Change of permitted use:
 - None



- 4. Permit Hearing for **Amendment** to Increase Production on **Existing Wells**:
 - One (1) well for The City of Pearsall (Production Permit #1393) located at N 28.895331, W -99.082534, in Frio County for Public Supply use. The total acreage of the property is 5.53. The well produces from the Carrizo Aquifer. The capacity of the well is 1,000 GPM. Total maximum annual production from the well will be 503.22 acre-feet based on number of connections. This is 1 of 4 permitted wells in the system. The original permitted allocation was 244 acre feet per year, this is an increase of 259.22 acre feet per year.
 - One (1) well for The City of Pearsall (Production Permit #2422) located at N 28.889072, W -99.090108, in Frio County for Public Supply use. The total acreage of the property is 0.78. The well produces from the Carrizo Aquifer. The capacity of the well is 598 GPM. Total maximum annual production from the well will be 503.22 acre-feet based on number of connections. This is 1 of 4 permitted wells in the system. The original permitted allocation was 306.74 acre feet per year, this is an increase of 196.48 acre feet per year.
- 5. Permit Hearing for **Amendment** to Change Location:
 - One (1) well for The City of Pearsall (Production Permit #1393) located at N 28.895331, W -99.082534, in Frio County for Public Supply use. The total acreage of the property is 5.53. The well produces from the Carrizo Aquifer. The capacity of the well is 1,000 GPM. Total maximum annual production from the well will be 503.22 acre-feet based on number of connections. This is 1 of 4 permitted wells in the system. The original permitted location was N 28.88539, W -99.089687, this is a distance of 1,081.55 feet from the abandoned historic well.
 - One (1) well for The City of Pearsall (Production Permit #2422) located at N 28.889072, W -99.090108, in Frio County for Public Supply use. The total acreage of the property is 0.78. The well produces from the Carrizo Aquifer. The capacity of the well is 598 GPM. Total maximum annual production from the well will be 503.22 acre-feet based on number of connections. This is 1 of 4 permitted wells in the system. The original permitted location was N 28.888592, W -99.089717, this is a distance of 214 feet from the abandoned historic well.
