- c) Permit Hearing for the following **Drilling/Production Permit Applications**:
 - One (1) well for Cat Hil Arrow S, LLC, & DJH Ranching LP, (Drilling Permit #3304 and Production Permit #3304) located at N 28.771944, W -98.376667, in Atascosa County for Industrial use. The total acreage of the property is 39,473.54. The well produces from the Carrizo Aquifer at a depth of 3,400 feet. The capacity of the well is 2,200 GPM. The total maximum annual production from the well will be 2,661.46 acre-feet based on 75% of the pump's capacity. This is one of four permitted wells on the property.
 - One (1) well for William M & Margaret Y Woodruff (Drilling Permit #3324 and Production Permit #3324) located at N 28.954530, W 98.779040, in Atascosa County for Irrigation use. The total acreage of the property is 100.00. The well will produce from the Carrizo Aquifer at a depth of 1,200 feet. The capacity of the well is 500 GPM. The total maximum annual production from the well will be 145.20 acre-feet based on 2-acre ft. This is one of two permitted wells on the property.
 - One (1) well for Black Creek Farms, LLC (Drilling Permit #3327 and Production Permit #3327) located at N 29.013118, W -98.992431, in Frio County for Irrigation use. The total acreage of the property is 1,161.53. The well will produce from the Carrizo Aquifer at a depth of 900 feet. The capacity of the well is 1,000 GPM. The total maximum annual production from the well will be 1,161.53 acre-feet based on 2-acre feet. This is one of two permitted wells on the property.
 - One (1) well for Black Creek Farms, LLC (Drilling Permit #3333 and Production Permit #3333) located at N 29.016944, W -98.993611, in Frio County for Irrigation use. The total acreage of the property is 1,161.53. The well will produce from the Carrizo Aquifer at a depth of 900 feet. The capacity of the well is 1,000 GPM. The total maximum annual production from the well will be 1,161.53 acre-feet based on 2-acre feet. This is one of two permitted wells on the property.



- One (1) well for Rosewood Resources, Inc (Drilling Permit #3338 and Production Permit #3338) located at N 28.860320, W -98.447720, in Atascosa County for Industrial use. The total acreage of the property is 318.89. The well produces from the Carrizo Aquifer at a depth of 3,000 feet. The capacity of the well is 1,000 GPM. The total maximum annual production from the well will be 318.89 acre-feet based on 2-acre ft. This is one of two permitted wells on the property.
- One (1) well for Rosewood Resources, Inc (Drilling Permit #3339 and Production Permit #3339) located at N 28.857222, W -98.454300, in Atascosa County for Industrial use. The total acreage of the property is 318.89. The well produces from the Carrizo Aquifer at a depth of 3,000 feet. The capacity of the well is 1,000 GPM. The total maximum annual production from the well will be 318.89 acre-feet based on 2-acre ft. This is one of two permitted wells on the property.
- One (1) well for Ray Doyon (Drilling Permit #3340 and Production Permit #3340) located at N 28.940196, W -98.722662, in Atascosa County for Irrigation use. The total acreage of the property is 373.69. The well produces from the Carrizo Aquifer at a depth of 1,600 feet. The capacity of the well is 1,000 GPM. The total maximum annual production from the well will be 373.69 acrefeet based on 2-acre ft. This is one of two permitted wells on the property.
- One (1) well for David G. & Suzanne E. Dickie (Drilling Permit # 3343 and Production Permit #3343) located at N 29.123095, W -98.551575, in Atascosa County for Irrigation use. The total acreage of the property is 86.75. The well produces from the Carrizo Aquifer at a depth of 520 feet. The capacity of the well is 500 GPM. The total maximum annual production from the well will be 173.50 acre-feet based on 2-acre ft. This is first permitted well on the property.

- e) Permit Hearing for **Amendment** to Change of permitted use:
 - One (1) well for Cat Hil Arrow S, LLC, & DJH Ranching LP, (Production Permit #1799) located at N 28.773157, W -98.334019, in Atascosa County for Recreation use. The total acreage of the property is 39,473.54. The well produces from the Carrizo Aquifer at a depth of 3,905 feet. The capacity of the well is 1,000 GPM. The total maximum annual production from the well will be 806.135 acre-feet based on 75% of the pump's capacity. This is one of four permitted wells on the property. The original permitted use was Industrial.
 - One (1) well for Cat Hil Arrow S, LLC, & DJH Ranching LP, (Production Permit #1800) located at N 28.740840, W -98.380318, in Atascosa County for Livestock use. The total acreage of the property is 39,473.54. The well produces from the Carrizo Aquifer at a depth of 3,900 feet. The capacity of the well is 300 GPM. The total maximum annual production from the well will be 362.93 acre-feet based on 75% of the pump's capacity. This is one of four permitted wells on the property. The original permitted use was Industrial.
- f) Permit Hearing for **Amendment** to Increase Production on **Existing Wells**:
 - One (1) well for Cat Hil Arrow S, LLC, & DJH Ranching LP, (Production Permit #1799) located at N 28.773157, W -98.334019, in Atascosa County for Recreation use. The total acreage of the property is 39,473.54. The well produces from the Carrizo Aquifer at a depth of 3,905 feet. The capacity of the well is 1,000 GPM. The total maximum annual production from the well will be 1,209.75 acre-feet based on 2-acre feet. This is one of four permitted wells on the property. The original permitted allocation was 806.135-acre feet per year; this is an increase of 403.615-acre feet per year.
